- Of the 20 counties where the great percentage of the population speaks Mon-Khmer/Cambodian, five are in California, four are in Washington and three are in Massachusetts.
- The percentage of the population of San Joaquin County, Calif. that speaks Mon-Khmer/Cambodian is nearly double that of any other county.
- Los Angeles County, Calif. has nearly three times the number of Mon-Khmer/Cambodian speakers than any other county in the United States.
- Mon-Khmer/Cambodian is the sixth most common language spoken in Rhode Island and the seventh most common language spoken in Maine.
- Mon-Khmer/Cambodian is the third most common language spoken at home in Davidson County, N.C. and Cowlitz County, Wash.
- In the United States, 1 of every 1,442 people age five and older speaks Mon-Khmer/Cambodian at home. In Rhode Island, this figure is 1 in 176 people, while in Massachusetts, 1 in 276 residents is a Mon-Khmer/Cambodian speaker.
- Within the counties, San Joaquin County, Calif. has the greatest rate of Mon-Khmer/Cambodian speakers (1 in every 55 residents), followed by Providence County, R.I. (1 in every 110 residents).
